ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Final Offer Price

- The Offer Price has been determined at HK\$0.25 per Offer Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).

Net Proceeds from the Share Offer

- Based on the Offer Price of HK\$0.25 per Offer Share and 500,000,000 Offer Shares, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting commission and other estimated expenses payable by the Company in connection with the Public Offer, are estimated to be approximately HK\$91.5 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “*Net Proceeds from the Share Offer*” in this announcement.

Applications and Indications of Interest Received

- The Offer Shares initially available under the Public Offer have been very significantly over-subscribed. A total of 21,147 valid applications pursuant to the Public Offer on (i) **WHITE** and **YELLOW** Application Forms; (ii) through **electronic application instructions** given to HKSCC via CCASS; and (iii) to the **HK eIPO White Form** Service Provider under the **HK eIPO White Form** service through www.hkeipo.hk or the **IPO App** have been received for a total of 3,054,480,000 Public Offer Shares, representing approximately 61 times of the total number of 50,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to the very significant over-subscription in the Public Offer and the slight under-subscription in the Placing, the reallocation procedures as described in the section headed “*Structure and Conditions of the Share Offer – The Public Offer – Reallocation and clawback*” in the Prospectus have been applied. As the Placing Shares are not fully subscribed and the Public Offer Shares are fully subscribed, a total of 50,000,000 Offer Shares will be reallocated to the Public Offer from the Placing, so that the total number of Offer Shares available from subscription under the Public Offer has been increased from 50,000,000 Offer Shares to 100,000,000 Offer Shares, representing 20% of the number of Offer Shares initially available for subscription under the Share Offer.

The Placing

- The Offer Shares initially offered under the Placing have been slightly under-subscribed for 0.91 time of 450,000,000 Offer Shares initially offered under the Placing. Following the reallocation described above, the final number of Offer Shares under the Placing allocated to 154 placees is 400,000,000 Offer Shares, representing 80% of the Offer Shares initially available under the Share Offer. A total of 25 placees have been allotted 5 board lots or less of Offer Shares, representing approximately 16.2% of 154 placees under the Placing. A total of 968,000 Offer Shares have been allotted to these placees, representing approximately 0.24% of the Placing Shares after reallocation. A total of 4 placees have been allotted 4 board lots of Offer Shares, representing approximately 2.6% of 154 placees under the Placing. A total of 128,000 Offer Shares have been allotted to these placees, representing approximately 0.032% of the Placing Shares after reallocation. No placees have been allotted with less than 4 board lots.
- The Directors confirm that, to the best of their knowledge, information and belief, no Offer Shares have been allocated to core connected persons, Directors or existing Shareholders (as defined under the Listing Rules) of the Company or any of its subsidiaries or their respective close associates (as defined under the Listing Rules) and are not any person or group of persons or any nominees of the foregoing, and none of the Offer Shares subscribed by the placees or the public who have subscribed for the Offer Shares has been financed directly or indirectly by any of the Directors, chief executives, Controlling Shareholders, substantial Shareholders or existing Shareholders of the Company or any of its subsidiaries or their respective close associates, and none of the placees or the public who have subscribed for the Offer Shares is accustomed to taking instructions from any of the Directors, chief executives, Controlling Shareholders, substantial Shareholders or existing Shareholders of the Company or any of its subsidiaries or their respective close associates in relation to the acquisition, disposal, voting or other disposition of Shares registered in his/her/its name or otherwise held by him/her/it.
- The Placing is in compliance with the placing guidelines for equity securities as set out in Appendix 6 to the Listing Rules. None of the Sponsor, the Sole Global Coordinator, the Joint Bookrunners, the Co-lead Managers, the Underwriters or their affiliated companies and the connected clients of the lead broker or of any distributor (as defined in Appendix 6 to the Listing Rules) has taken up any Offer Shares (whether in their own names or through nominees) for its own benefits under the Share Offer.
- The Directors further confirm that (i) there will not be any new substantial Shareholder of the Company immediately after the Share Offer; (ii) the number of Shares in public hands will satisfy the minimum percentage of 25% as required under Rule 8.08(1) of the Listing Rules; (iii) the Shares will be held by at least 300 Shareholders at the time of the Listing in compliance with Rule 8.08(2) of the Listing Rules; (iv) no placee will, individually, be placed with more than 10% of the enlarged issued share capital of the Company immediately after the Share Offer; and (v) the three largest public Shareholders of the Company do not hold more than 50% of the Shares in public hands at the time of Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules.

Over-allotment Option

- In connection with the Share Offer, the Company has granted the Over-allotment Option to the Placing Underwriters, exercisable by the Sole Global Coordinator (for itself and on behalf of the Placing Underwriters) pursuant to the Placing Underwriting Agreement at any time from the Listing Date until 7 December 2019, being the 30th day after the last day of lodging applications under the Public Offer, to require the Company to allot and issue up to an aggregate of 75,000,000 additional Shares, representing 15% of the total number of Offer Shares initially available under the Share Offer, at the Offer Price to cover over-allocations in the Placing and/or to satisfy the obligation of the Stabilising Managers to return securities borrowed under the Stock Borrowing Agreement, if any, on the same terms and conditions as the Offer Shares that are subject to the Share Offer. There is no over-allocation in the Placing. Therefore, no Offer Share has been and will be borrowed by the Stabilising Managers under the Stock Borrowing Agreement and the Over-allotment Option will not be exercised.
